Definition of Sessions:

General: All Skaters permitted, provided skater is currently enrolled or has passed USFS Learn to Skate (LTS) Basic 1. Skaters below LTS Basic 4 must be in coaching lesson for 30 minutes of the session.

Moves: All Skaters having *passed* Learn to Skate (LTS) Basic 4 and above permitted.

Costs

All skaters wishing to contract ice are required to contract a minimum of one (1) hour of ice time per chosen contracted day. For every hour of ice contracted, a member may also contract an additional 30 minutes of ice. Moves sessions are separate and do not count toward the one hour minimum. This means skaters may contract for one (1) hour, 1 hour 30 minutes, or 2 hours on each (or either) day.
